

The Federal Jeanne Clery Disclosure of Campus Security Policy and Crime Statistics Act, or Clery Act, and the Commonwealth of Pennsylvania Act 180, Uniform Crime Reporting Act, requires the publication and distribution of the following information, as well as keeping an open crime log and fire log that is available for inspection in Campus Police Headquarters at 119 W. Greenwich Street. Information for this report was compiled by the Department of Campus Police local criminal justice agencies, and the Division of Student Affairs. Campus crime, arrest, and referral statistics include those reported to the Office of Campus Police, to designated campus officials, and/or to local criminal justice agencies. The statistics include crimes that have occurred on campus, as well as on public property and non-campus buildings around the Moravian College Campus.

It is important to note that the crime classifications for which colleges and universities must provide statistics differ under state and federal law. Statistics for certain crime classifications might appear to be different. For example, the federal statistics for motor vehicle theft differ from the state statistics for the same category because the federal classification includes attempted motor vehicle thefts, while state law requires institutions to separately report attempted motor vehicle thefts.

## The Pennsylvania College and University Security and Information Act Campus Crime Statistics for Moravian College

The Pennsylvania College and University Security and Information Act requires the release of crime statistics and rates to students and employees, and it requires that those statistics be available to applicants and new employees upon request. The rate is based on the actual number of Full Time Equivalent (FTE) students and employees, which is calculated according to a state-mandated formula. The formula is the number of FTE students plus the number of FTE employees (faculty/staff). The rate is obtained by dividing this figure into 100,000 and multiplying the quotient by the individual statistics to produce the crime rate per 1000,000 persons in each category. The index in the table below is based on incidents per 100,000 FTE.
