Long-term Disability Insurance

- A cash benefit of 60% of your monthly salary (up to \$10,000) starting after a period of 180 days of disability and continues up to the maximum benefit period.
- Includes *EmployeeConnect*SM EAP services, which give you and your family confidential access to counselors as well as personal, legal, and financial assistance.
- Program Services include:
 - Unlimited, 24/7 access to information and referrals
 - In-person help for short-term issues; up to five sessions with a counselor per person, per issue, per year.
 - One free consultation with a network attorney (with subsequent meetings at a reduced fee)
 - Access to staff financial experts
 - Online tools, tutorials, videos and much more

ADDITIONAL DETAILS

Pre-existing Condition: If you have a medical condition that begins before your coverage takes effect, and you receive treatment for this condition within the 3 months leading up to your coverage start date, you may not be eligible for benefits for that condition until you have been covered by the plan for 12 months.

Coverage Period for Your Occupation: 24 months. After this initial period, you may be eligible to continue receiving benefits if your disability prohibits you from performing any occupation for which you are reasonably suited through your training, education, and experience. In this case, your benefits may be extended through the end of your maximum benefit period.

Maximum Benefit Period: Up to age 65 or Social Security Normal Retirement Age (SSNRA), whichever is later.
